# Planning Process of Regional Resilience Initiative 2015

As of end February, eight National Societies submitted their plans of action with priority activities to be supported for each of the four components of the initiative (CSR, Humanitarian Diplomacy / Communications, Gender and Diversity as well as Disaster law). The team held a series of internal meetings in February to review all proposed activities against the overall plan of the RRI and assess its overall feasibility. A draft Annual Work Plan was formulated and validated in principle by the Steering Committee Meeting participants held in Bangkok on 2 March 2015. Such meeting was held with the participation of Thai Red Cross (Dr. Barlee as the Chair of the CSR Forum), Canadian Red Cross and the Canadian Government. PMI and Myanmar RC as well as AHA Centre also joined a session through conference call to share their experience and provide technical recommendations to the Steering Committee Members.

Following the validation of the draft plan, feedback was provided to National Societies through their respective country delegations in March and the final version of the plan was submitted to the Canadian Red Cross on 23 March. CRC is now reviewing the plan for submission to the Canadian Government.

The chart below shows the support committee to National Societies for in-country activities, based on the latest data available as of 31 March 2015. The team remains available throughout the year to discuss any new proposed activity.

### **Cooperation with AHA Centre within ACE Programme**

Preparations continued in March for RCRC upcoming contribution to the AHA Centre Executive (ACE) Programme, taking place from February to August 2015. 16 participants from 8 NDMOs across South-East Asia are participating in this capacity-building programme. AHA Centre is providing two opportunities for RCRC to be involved:

- IFRC and PMI will jointly host an RCRC induction training for the ACE Programme trainees on 27-29 April 2015 in Semarang (in the PMI training centre). This will be an opportunity to train the government representatives on RCRC, our activities and the way we operate, both in emergencies and in promoting community safety and resilience. Disaster Law and Humanitarian Diplomacy will also be part of the programme. In addition, the trainees will have a change to learn from PMI programming through field visits in Yogyakarta, Padang and Aceh, to be held after the training in Semarang.
- AHA Centre is welcoming participants from National Societies from ASEAN Member States to join their government representatives in selected modules of the ACE Programme curriculum. A selection process for such NS participants was launched mid-March and the final list will be announced early April 2015.

# **Disaster Law**

Introductory session to disaster law at CVTL Headquarters

February and March have been busy months for disaster law in South East Asia, with some key developments taking place across the region. In Timor Leste, IFRC and Cruz Vermelha de Timor Leste (CVTL - Timor Leste Red Cross) participated in the Humanitarian Country Team (HCT) disaster response simulation exercise at the end of February. The outcomes of this exercise included recommendations to strengthen the national legal and policy framework for DM and response.

An OCHA civil-military coordination workshop took place in Dili that same week, which included a session on IDRL presented by the IFRC Regional Disaster Law Delegate, who was also on the facilitation team for the simulation exercise. CVTL also hosted a disaster law introductory session at their new headquarters, and discussions were held between CVTL, IFRC, UNDP and the NDMD (Ministry of Social Solidarity) about the ongoing role of IFRC and CVTL in revising the national DM policy and developing the new DM law, and the possibility of holding an IDRL workshop in Dili later in 2015. In **Cambodia**, the new disaster management law was submitted to the National Assembly for final comments and approval in February 2015. The Regional Disaster Law Delegate joined the Head of Regional Delegation on mission to Cambodia that same month, to undertake discussions on disaster law activities with the Secretary General and Head of Disaster Management of Cambodia Red Cross. Follow-up activities may include preparing dissemination and information materials about the new law once it is adopted, and also working with Cambodia Red Cross, the National Committee for Disaster Management and external partners such as UNDP on developing the implementing sub-decrees for the law. It is anticipated that the law will be approved later in 2015.





In early March, meetings on **disaster law developments in the Philippines** were held in Manila with key stakeholders including Philippine Red Cross, the Department of Foreign Affairs, UN OCHA and the Philippines Congress. An IDRL report is currently being finalized, which will feed into a review of the National Disaster Risk Reduction and Management Act from 2010. The idea of establishing a Philippines International Disaster Law Association was also discussed, as well as plans to implement a long-term proposal which will incorporate ongoing work on IDRL and also new initiatives in Law and DRR.

A session on 'Disaster Law in the Asia Pacific: A Humanitarian Imperative' was held at the **International Humanitarian Law Conference in Kuala Lumpur**, where the Assistant Secretary General for the United Nations and International Organizations from the Philippines Department of Foreign Affairs spoke about IDRL developments in the Philippines and experiences after Typhoon Haiyan. The conference included legal advisors and representatives from National Societies and governments in South East and East Asia, including from the Philippines, Myanmar, Malaysia and Vietnam.

# Activity 1.6 Build Warehouse/Storage Location for Water Purification Units and Flat-bottomed boats (activity completed in Q1/2015)

The construction of the final phase according to the contract is completed. Relief and Community Health Bureau by The Thai Red Cross Society (RCHB) is processing the payment process. The financial document should reach the project team by the beginning of April.

During the final phase hand-over, the team tested the operation functions, equipment functions, safety issue, etc. The committee team found that some installed functions eg. boat racks which designed to shelf flat-bottomed boats (2-story) have operation and safety problems. The hoist equipment also has problem as it sway while pulling up boats.

Within the same week, the committee had a meeting with the Architect who design the warehouse and committee team to discuss how to solve these problems and what are some additional function that needed to be installed. The team went to Angthong warehouse with the Architect on 20 March to re-test functions, equipment and make the conclusion on what are additional adjustments, equipment, signage installation needed. This will incur additional expenses which RCHB needs to discuss and locate the budget internally.

# Activity 1.20 Disaster Relief Operation Response Team Seminar – a collaboration session with Bangkok Metropolitan Administration (BMA)

The session was conducted with about 22 participants joining the round-table discussion from Erawan center, Central DDPM, Bangkok Fire and Rescue Department, Head of 6-BKK district representing 50 BKK districts, National Institute of Emergency Medicine (NIEMS), Health Department and Relief Community and Health Bureau(RCHB) team.

The summary of agreed collaboration for Bangkok Metropolitan Administration (BMA) is the following:

- <u>Medical and Public Health Services</u>: Erawan Center will be the center for incident report, coordination and communication center during normal situation and emergency situation. During large scale of emergency situation, the center will set up emergency operation center for medical and public health. There are 3 levels of operational plan: Erawan 1 private and public hospital plus 57 network hospital, Erawan 2 private and public hospital and network outside BKK and perimeter area, Erawan 3 there are specialist which may also work in level 2 or 3.
- <u>Other Types of Emergency Service</u> (all except medical and public health) : All emergency assistants under BKK area are services through Bangkok Fire and Rescue Department, other type of relief assistance to vulnerable group children, elderly, disabled people are through Social Development and Human Security Office. The relief assistance will be based on the level of disaster.
- <u>Relief assistance to immigrants</u>: TRC with the equality principle, helping all without discrimination provides consumer goods eg. Fire relief kit, family kit, mosquito net, rice, clothing, and donated items. For example in case of fire, TRC provides 1 fire relief kit per 2 persons, 1 set of family kit per a family depending on the basic evaluation.

<u>Supports needed from BKK districts to immigrants</u>: District to confirm the status of immigrant group as disaster/emergency victims by asking questions to find out information eg. number of household, family member, special group, etc. In the case that district office has not/cannot get the information for relief assistance, the district office will help TRC to coordinate with the contact person for TRC to be able to survey and evaluate the needs from this group.



### Activity 1.37 Disaster Preparedness for Senior Citizen

The workshop of disaster preparedness for senior citizen was conducted in Ayutthaya Province on 6 March. Total participant was 62 people (male 26/female 36). Participants are senior citizen group, age 60 and over with good health and able to take care of themselves. However, a few of them are illiterate but they receive the help from group member and staffs. Each session, participants are divided into a group of 10 people with one RCHB staff per group. Overall, the unit sees the improvement from participants after the training as reflected from the knowledge / understanding score. All participants said they could apply the learning in real life.

#### Activity 1.15 Improve and upgrade Disaster Database and IT system (GIS)

RCHB with GIS allied network organized a meeting with Department of Disaster Prevention and Mitigation (DDPM), King Mongkut's Institute of Technology Ladkrabang (KMITL) and 24 local government units and relevant organizations to discuss about the GIS pilot testing cooperation for Ayutthaya province. The meeting took place on 31 March 2015 in Ayutthaya Town Hall, and chaired by the Governor of Ayutthaya province.



During the meeting, it was decided that the Provincial Department of Disaster Prevention and Mitigation(DDPM) will be the main coordinator from Ayutthaya province and will set up the project committee to help develop the system. The province has statistic and useful information that can provide to GIS team. The suggestion from the provincial side is to pilot at the lowest area at Sena district.

Suggestions from Ayutthaya on the requirements:

1. Effective Warning system

2. Geographic information: mainstream and tributary, canals, contour information to help forecast and planning

- 3. Relief assistance eg. relief kit distribution.
- 4. Prevention system with details and accurate information.
- 5. Relief assistance resources eg. Human resources, boats, generator, food.
- 6. Relief assistance in tracking system and recovery system.

### School Based Disaster Risk Reduction Pilot Project in Myanmar

School based Risk Reduction Initiative has been rolled out in Myanmar at 10 schools. The developed module and tools will be tested at those selected 10 schools for almost one year.

In this connection; MRCS organized one day consultative meeting on 23 March to collect the feedback on developed module and tools from national level partners; government official. Total 30 people were at room and out of them 16 represented teachers; Township Education Authority and Education development office.

These representatives were outlined their expectations from MRCS as:



- Field Level Trainings for Schools, Township staff and other local organisations
- Conducting drills and evacuation plans. Ensuring each school in the coverage area has a DM Plan.
- Production and dissemination of IEC material
- Providing Emergency Response equipment and support.
- Resource support for emergency preparedness to other agencies
- As active member of local committees, it is expected that MRCS will facilitate formation of local committees for DRR

Those feedbacks will also support to finalize the module and tools. The learning of this implementation along with other National Societies like Thai RC, Philippines RC, Timor Leste Red Cross, Lao Red Cross; Indonesia Red Cross and Cambodia Red Cross will help to finalize the module and tools in the first quarter of 2016. This is belief that this module and tools will put our National Societies in the Centre of School based initiative in their specific country context.

One of the school will integrate YABC (Youth as Agent for Behavior communication) to establish linkages between students of school and youth of the host community. The process of YABC integration into ongoing School based Risk reduction will be documented at the end of the project for the future reference.

# Training/workshop/meeting

### Malaysian Red Crescent Climate Change Training 14 – 16 March 2015

SEARD sent one team member to lead the three day training from 14-16 March 2015 on climate change as per the request of Malaysian Red Crescent(Sarawak Branch). SEARD facilitated this training programme along with Malaysian Red Crescent staff member from Headquarter who were trained by SEARD in 2013. The participants were 20. Total 8 Male and 12 female. Participants show their interest in learning about how to adjust climate smart components into their current activities. They understood the causes and impact of climate change in generally. Participants also got a clear understanding of early warning early action in term of Disaster risk reduction and health.
