

Objectives

Increase comprehensive assistance to victim of trafficking and safe migration in Indramayu District, West Java-Indonesia





Target population/beneficiaries

- 1. 175 victim of trafficking cases access identification, return, recovery and reintegration assistances.
- 2. 10.500 students grade 7-12 have KAP on trafficking and safe migration in 15 sub-districts of Indramayu.
- Increase coordination between stakeholders and better regulation on comprehensive assistance to victim of trafficking and safe migration programmed.

Achievements

- 1. 66 victime of trafficking cases gained access for assistances identification, return, recovery and reintegration.
- 2. 23.456 students grade 7-12 have KAP on trafficking and safe migration in 15 sub-districts of Indramayu.
- Develop action plan of trafficking task force in 2016 and mapping of the trafficking situation in indramayu.

Key obstacles and challenges

- 1. The Government of Indramayu in particular trafficking task force is still weak in terms of the budgeting process for prevention and handling cases. Needed an alternative safe migration pilot villages (small scale)
- Intimidation made by the traffickers to the VoT, creates discomfort and fear of the community to report.







Lessons learned

- 1. Participations from local community to pursue cases of trafficking to justice, very importan in helping other victims are being trafficked.
- 2. The dissemination of trafficking issues and safe migration to school was quite successful because the issues presented is become a common concerns of local community





Next steps

- Strengthening governance Indramayu in planning and budgeting program
- Providing assistance safe migration pilot villages (small scale)
- 3. In the face of threats from traffickers by involving professionals from the legal aid organization for victims of trafficking, especially the issue of child prostitution.
