

LEVEL	Definition
SYSTEMIC	CHANGES TO THE SYSTEM TO WORKS AS A WHOLE ESTABLISH POLICIES TO ENSURE DRM INTEGRATION INTO PLANNING & BUDGETING.
PROCEDURAL	PUT IN PLACE IMPLEMENTATION PROCEDURES, MECHANISMS, AND PROTOCOLS INCORPORATE DRM CONSIDERATIONS INTO THE SUBNATIONAL PLANNING CONFERENCE
INSTITUTIONAL	CHANGES TO THE SUBNATIONAL GOVERNANCE STRUCTURES REVITALIZATION OF THE SECTORAL AGENCIES' RECEPTIVENESS OF THE DRM CONSIDERATIONS


