

- Federation policy review -

Status of existing Federation policies and recommended next steps

1. Background

The IFRC currently has 23 policies that have been adopted by the General Assembly or Governing Board and are binding and applicable to all National Societies and the IFRC Secretariat. In 2011, the IFRC Secretariat engaged a consultant to undertake a review of these existing policies. The aims of the review were to assess the status, relevance and level of application of those policies and to gauge their consistency with Strategy 2020 and existing Movement policies. Based on the review, existing policies were categorized as '**obsolete**', '**needs updating**' or '**is up-to-date**', as reflected in the table below.

Subsequently, the 2013 General Assembly adopted an "IFRC Policy Framework" and requested the launch of a review process of the existing policies against the new Policy Framework. Also, the General Assembly recommended to set up a governance body to oversee the review of existing policies and to act as a governance "clearing house". Furthermore, the General Assembly recommended that the Governing Board set up ad hoc advisory bodies on a case-by-case basis for the creation and further revision of IFRC policies.

2. Status update of Federation policies

Since the 2013 GA decision, progress on cancelling policies or conducting an overall revision of the policy body is on-going. As reported in this paper, the Secretariat has undertaken a brief review of the consultant's findings from 2011 to provide more current advice from relevant internal file holders. The conclusions of that review are reflected in the table below, under 'status in 2017'. Using the 2011 review and the 2017 status update, recommendations are proposed for the Governing Board Working Group on Governance Excellence as to next steps. These include calling for several policies to be retired as obsolete and also directing the Secretariat to consult appropriately and develop a phased plan as to whether and how to update and revise other policies (in light also of other potential policy priorities) in order to build a relevant and coherent body of policy for the Federation.

2.1 Obsolete Policies

Four Federation policies are recommended for retirement as obsolete:

2.1.1 Malaria control policy

IFRC and RC/RC National societies are using both WHO malaria control recommendations and national (MoH) malaria control policy. In light of these external references, it is considered that IFRC's malaria control policy should not be updated and the old version officially made obsolete as it is no longer aligned with WHO recommendations. Since this policy was adopted only by the Governing Board, that body could also retire it directly.

2.1.2 Social welfare policy

The social welfare policy is considered to be out of date and no longer relevant. The realm of social welfare has changed significantly, newer priorities are e.g. ageing populations or multicultural societies. If governance/ leadership feels that an updated social welfare policy should exist, it should be based on an in-depth analysis on the policy need in the realm of social welfare that goes beyond the direction of S2020 and only if there are controversies that call for a clear positioning of the organization. Therefore, the current policy should be officially retired by the General Assembly.

2.1.3 Development cooperation policy and development policy

The development cooperation policy (1997) and the development policy (1995) are the oldest IFRC policies. Since their adoption, other normative instruments, such as the National Society Development Framework (2013), have been approved by the General Assembly. The Framework does not refer to the policies and provides more up-to-date direction for National Society development and therefore practically replaces the main content of the policies. Furthermore, a National Society development compact is being developed that will largely replace the content of the development cooperation policy. Therefore, these two policies should be retired by the General Assembly.

2.2 Policies needing updating

The updated analysis categorised 14 policies needing updating and two policies which are already under review with the aim of bringing a reviewed/ updated version to the General Assembly 2017. The fact that there are 16 policies out of 23 requiring a review reflects the general 'age' of Federation policies. The majority of our policies are from the late 1990s or early 2000s, i.e. 15-20 years old.

Some of these policies have also been identified as requiring updating already in earlier reviews (e.g. the 2008 policy audit of disaster policies). The reviews have identified the need to update the language, add references, create better coherence between policies etc. However, those policy revisions had been postponed due to institutional changes and processes. Now with the IFRC Policy Framework in place and with a dedicated Policy and Diplomacy Unit established in the Secretariat, it would be a suitable time to take action to review and update those individual policies that are still relevant.

2.3 New policies to be developed

The update of policies should also take account of proposals for new policies that may be required, either for the IFRC or for the Movement as a whole, in order to prioritize the order of work. For example, suggestions have been floated (with an eye to the statutory meetings in 2019) to develop new IFRC policies on the environment, responsible use of data, cash transfer programming and pandemic response, as well as a Movement policy on accountability to affected populations and a revision of Movement guidance on civil-military relations. These proposals need to be assessed¹ and well consulted.

¹ The IFRC Policy framework defines that Federation policies should be created only in areas which meet at least one of the below criteria. These criteria should therefore be considered when considering new policy development and reviewing current policy:

- require clear guidance and positioning because they describe a core business or cross-cutting area with specific characteristics of the Red Cross and Red Crescent;
- require clear guidance and positioning because they describe a work area, where National Societies enter a new field;
- describe a specific approach, e.g. in order to assure quality standards;
- require clear boundaries on what to do and what NOT do;
- require clear guidance and positioning because of controversy;
- bear high risk – reputational, financial, legal, ethical or other.
