### **BUILD SAFELY :** School Safety mapping









Through various activities, the MRCS contributes to the three pillars of the Comprehensive School Safety Framework. Activities in schools are embedded into more general programmes implemented after emergencies or as development initiatives and covering various sectors such as disaster risk reduction, health, water and sanitation, livelihoods and youth empowerment




Second activity : ASEAN Disaster Law Academic Seminar (September 2018)

**Outcome**: Enhance knowledge sharing on different climate smart DRM policies & tools implemented across ASEAN, based on best practices in the region, for the benefit of policy-makers and other relevant stakeholders

**Target participants**: academics and students from academic institutions in ASEAN, NDMO staff, non-government DRM practitioners, Red Cross Red Crescent national societies, legislative drafters



### **PROTECT : Gender-Based Violence in Disasters**

(Concept Note endorsed at ACDM meeting in Vientiane in April 2017)

Key contribution to *"ensuring social protection and establishing social safety nets in the context of disasters."* 

- Research conducted in Indonesia, Lao PDR and the Philippines
- Initial report shared at the ASEAN <u>Consultation Meeting</u> held in Jakarta on 2-3 May 2018
- Final report coming soon

#### Next steps:

- Follow-up of recommendations at regional and country levels
- Expansion of the research to Cambodia and Viet Nam





- Resilience Library as a knowledge hub among Red Cross Red Crescent and key partners (including ASEAN) in the region


